# **COURTROOM**

I have qualified and testified as an expert on origin and cause of fires, fire scene re-construction and explosives in Justice, Municipal, Superior, Civil, and Federal Courts, civilian and military courts. Have testified for both prosecution and defense in criminal cases.

During the past 40 years I have investigated approximately 2000+ fires and explosions to determine their origin and cause.

I have assisted in/or personally set fire to 450+ structures (single and multiple story), 500+ vehicles (Aircraft, busses, trucks and automobiles), 150+ training modules and numerous grass/vegetation fires to view the fire and observe the scene before during and after the burn. Some of the structures have been multi-story. Explosives have initiated some of the fire sets. Some of the vehicles have been new, and some were constructed with other than U.S. specifications. Many of the structures have been furnished. I taught at the advanced explosives identification class in Tulare yearly. (2006-2017)

Five years as a police officer with the Oroville Police Department, seven years as a resident deputy sheriff with the Mendocino County Sheriff's Department, six years as a firefighter/investigator/line officer and chief officer with the Covelo Fire Department, three years as a demolition specialist with the California Army National Guard, Combat Engineers. Thirteen years as an investigator for the U. S. Air Force Office of Special Investigations and eighteen years as an Arson-Bomb Investigator with the California State Fire Marshal's Office.
